Study on Emissions Trading Scheme Legal Framework (PMR CS-5)

National Reform Plan on Natural Resources and Environment

published in the Royal Thai Government Gazette on 6 April B.E.2561 (2018)



Environment Reform Issue 3:

Encouraging all sectors to engage in addressing climate change

Provides a mandate to the Government to develop "Climate Change Act B.E." to be published within 3 years (2018-2020) and to include provisions on, among others,

- Climate change impact / risk assessment of large-scale government investment projects and counter-measures
- Central database on GHG emissions in Thailand and area-based risk of climate change
- Appropriate mechanism[s] to provide economic incentives to reduce GHG emissions by private sector











Study on Emissions Trading Scheme Legal Framework (PMR CS-5)

Objective:

To support and enable the Government to make practical formulation of appropriate legal instruments and institutional arrangements for establishing the ETS, in line with national circumstances

Tasks:

- Comparative analysis of policies, legislation, regulations, and institutional arrangements in relation to the ETS
- Legal assessment of existing policies, legislation, regulations, and institutional arrangements in Thailand
- Recommendations on the formulation of appropriate legal framework and draft legislation for the ETS
- Identification of potential impacts from the implementation of the draft legislation and recommendations on regulatory impact assessment (RIA) to support decision-making

Period of study:

August 2017 – September 2019

Expected outcome:

Recommendations on the appropriate legal framework for the ETS to be proposed as a Chapter under the Climate Change Act B.E.... (under consideration by the Ministry of Natural Resources and Environment)


